

Electricity tariffs and charges from 1 July 2026

Fremantle Ports provides a range of electricity tariffs and charges to support the supply of power to port users. These rates cover electricity usage for shore power, facilities, and infrastructure connections provided to customers, businesses, and organizations operating within the port.

Each tariff has eligibility requirements that are outlined below the table and should be reviewed to ensure the correct selection is made for your organization. You may change your tariff to one for which you are eligible by providing at least 30 days' written notice before the 10th of each month. The selected tariff must then be retained for a minimum period of 12 months.

Business Plan Fifty (L3) Tariff

For sites using at least 50,000 units p.a. (≈ 137 units/day), connected at low/medium voltage (240/415V).

Community Service Plan® (C1) Tariff

The Community Service Plan (C1) tariff is a Government-regulated electricity tariff specifically designed for small voluntary and charitable organisations.

Eligibility criteria

To be eligible for the C1 tariff, your organisation must meet the following requirements:

- Your organisation is voluntary and non-profit, providing a public service and is available to any member of the public without discrimination
- Your organisation has endorsement by the Commissioner of Taxation as income tax exempt under Subdivision 50-B of the Income Tax Assessment Act 1997
- Your organisation is not a Commonwealth, State or Local Government department, agency or instrumentality, and does not receive majority funding from any of these entities

Applies to unmetered low-load services such as telecommunications infrastructure (e.g., NBN equipment).
